Student Images

Occasionally, we may take photographs of the children at Whitmore Primary School & Nursery. We use these images as part of our school displays and sometimes in other printed or digital publications. We will also use them on our school/trust website, and other social media sites.

If we use photographs of individual pupils, we will not use the name of that child in the accompanying text or photo caption. If we name a pupil in the text, we will not use a photograph of that child to accompany the article. If a child has won an award and the parent would like the name of their child to accompany their picture we will obtain permission from the parent before using the image.

Learning Journeys, Annual Reviews and Records of Achievement are used to inform you of your child's progress throughout school. These are sent home annually. Photographs of individuals, groups or classes of children may appear in these records.

From time to time, Whitmore Primary School & Nursery may be visited by the media who will take photographs or film footage of a high profile event. Children may appear in these images, which will sometimes be published in local or national newspapers, or on approved websites.
